17:57 Absences: Kim made a motion to excuse Steve's and Robert's absences, and Phyllis seconded the motion. There was no opposition.

17:58 New Board Member: Amy welcomed Chad to the Board.

17:59 Marquee: Signa is willing to change the messages on the marquee and will coordinate with Loretta on keeping the messages up to date.

18:02 Minutes: Phyllis made a motion approve the minutes from August 19, 2019. Chad seconded the motion, and there was no opposition.

18:03 Treasurer Issues: As Steve isn't here, Amy reported that \$3,329 was deposited into our account from the PID recently, and more receipts still need to be sent to the County for processing.

18:08 Maintenance Issues: Robert will talk about maintenance in October. Becky requests a piece of stainless steel to replace the men's outdoor restroom. Signa said she will speak to Greg about replacing the mirror. Kim says we need to find someone else to take care of the snow shoveling for the season, as Larry won't be available. Amy said she'd let Robert know. Signa suggested advertising in the PV Times, website, etc. for someone to take care of our snow removal this year. Amy said we would talk about storage in the historic gym and skylight cleaning in the next meeting. Dustin will try and locate when the skylight cleaning was last done.
